

SimBiotic Software License Agreement

The software included in this package or which you downloaded, which may include but is not limited to EcoBeaker™, EcoBeakerHS™, EvoBeaker™, OsmoBeaker™, NerveWorks™, and Mitosis & Meiosis Demystified™, is subject to the following license agreement.

Any use of this software indicates your acceptance of the following terms. If you do not agree with these terms you should immediately return the package to SimBiotic Software, unused and with the software envelope unopened, or, if you downloaded the software, immediately erase the download and send a signed and notarized letter testifying to the erasure, and your money will be refunded

In return for payment of the license fee for this software product, and for those using EcoBeakerHS who did not order directly from SimBiotic Software, upon receipt at SimBiotic Software of a completed registration form (available at www.simbio.com), Customer receives from SimBiotic Software a license to use the enclosed software subject to the following terms and conditions.

1. If this license was purchased for a single user, the enclosed copy of the software may be used simultaneously on only one (1) computer, and may not be used at all in a classroom or for teaching in an official course at an educational institution, except by the owner of the license for their own education (i.e., if the owner is a student they may use it themselves).

9. Term
